DEP Small Business Advantage Grant Open Now

The [Small Business Advantage Grant](#) program opened July 25, 2017 and will remain open through June 30, 2018, or until funds are exhausted. The program provides 50% matching grants, up to a maximum of \$9,500 (\$7,000 for lighting-only upgrades), to enable Pennsylvania small businesses to purchase energy efficient or pollution prevention equipment or adopt waste reduction processes.

Regulatory Updates

Open for Comment: Proposed Regulations for Industrial Cleaning Solvents

DEP is accepting comments on the proposed rulemaking for the Control of VOC Emissions from Industrial Cleaning Solvents. Comments will be accepted until August 21st and may be submitted via [DEP's eComments](#).

Proposed Safe Drinking Water Changes

DEP is proposing to [amend](#) the Department's Safe Drinking Water regulations to:

- Incorporate the remaining general update provisions that were separated from the proposed Revised Total Coliform Rule
- Amend permit fees and add new annual fees

- Add new amendments to establish the basis for issuing general permits
- Address concerns related to gaps in the monitoring, reporting and tracking of backup sources of supply

"Waters of the US" Revised Definition

EPA and the Army Corps of Engineers have proposed a rule intended to review and revise the definition of "waters of the US". This rule seeks to reexamine how the 2015 Clean Water Rule defined what waterways could be regulated by the federal government.

Other Updates

Volkswagen Mitigation Funds

Pennsylvania is in the process of being certified as a beneficiary to be able to distribute the Commonwealth's share of mitigation funds. Over \$118 million will be available in Pennsylvania to fund specified categories of projects that repower diesel vehicles, engines or equipment with new engines or replace older diesel vehicles, engines or equipment with new vehicles, engines or equipment.

Small businesses will be eligible to apply for project funds and it is anticipated that applications for funds will be available in 2018.
